
## **The Big List of Small Business Tax Deductions**

#### CONTRACT LABOUR

Fees of hired freelancers or independent contractors

#### COST OF GOODS SOLD OR COST OF SERVICE



- Cost of all inventory sold during the year
- Cost of services during the year directly tied to revenue generation

#### DEPRECIATION

Depreciation cost of larger assets in your business (equipment, etc.)

#### EDUCATION

- Classes to improve skills in your fieldSeminars
  - Webinars
  - Trade/professional publication subscriptions
- Industry books
- Workshops to increase your expertise/skills
- Transportation expenses to/from classes

Cash donations to a <u>qualifying organization</u>

Deduction amount depends on the type of plan

Insurance premiums (self employed may also deduct their spouse and dependents)
